Please duly fill the present disclaimer truthfully and return it to Haven Diving Center before diving.

The diver is fully responsible and takes public and criminal liability for the contents herein declared.

I, the signatory, _____ hereby claim that I am fully aware that scuba dives performed with mixed gas (Enriched Air Nitrox – EANx, Trimix, Heliox, Triox) can imply inherent risks and danger which may result in serious injury or death, if they have not been performed with the required training and according to the suitable procedures.

I also am aware that any action performed by dive guides, instructors and staff members of HAVEN DIVING CENTER Arenzano, will aim to guarantee the best possible conditions for scuba diving at the highest possible safety level. The signatory will be the only individual responsible for his/her personal safety while committing him/herself to follow a correct dive plan and profile.

I also declare that:

- 1) I own the due medical certification required for diving activities, that is still valid all throughout the current year.
- 2) I am in good health condition, I am not a sick person, I have not taken any drugs or medicines, or drunk alcoholic drinks during the past 24 hours before diving.
- 3) I have eaten moderately and not excessively during the last past hours and immediately before diving.
- 4) I am aware that scuba diving is absolutely inadvisable for pregnant women.
- 5) I own a scuba diver certification valid for recreational dives that is internationally recognized, certifying my ability to perform dives at a depth of 40 m. or below **and the required certification of Wreck Diver for diveplans including any wreck penetration.**
- 6) I will strictly follow the dive plan as set by HAVEN DIVING CENTER and as foreseen for any dives performed on the wreck Haven. I will not dive beyond the depth I am allowed to by my scuba dive certification.
- 7) I will provide truthful and correct information about the dive certifications I own.
- 8) I make myself personally and directly responsible for the correct functioning of my own scuba dive gear and equipment, for its right usage and for its suitability to all scuba dive activities which have been planned.
- 9) I will follow without exception all the guidelines given by HAVEN DIVING CENTER, according to the regulatory information of the Ordinance n. 305/99 (Haven Regulations) and n. 229/98 (accompanied dives) and n. 75/14 dated 14.04.2014, issued by the Coast Guard of Genova. The direction of HAVEN DIVING CENTER will be free to prevent me from diving in case I would be found unsuitable or undisciplined.
